'OUR GIBRALTAR' COMPETITIVE EXHIBITION 2021

Organised by Gibraltar Cultural Services (GCS), for the Self Determination for Gibraltar Group (SDGG), in association with the Gibraltar Photographic Society (GPS) & The Fine Arts Association (FAA)

1. GENERAL

- This competition is open to Gibraltarians and residents of Gibraltar aged 16 and over (as at 25th August 2021).
- Works must be original and not entered previously in any Ministry of Culture (MOC), GCS, GPS Annual Exhibition and FAA competition. Any previous competitive work will not be accepted.
- Participants may submit a maximum of **6 entries in total but no more than 4 per category**.
- The theme is: **"OUR GIBRALTAR"**. The entry theme is open to interpretation and only serves as a guide for artists.
- Accepted works may not be removed from the exhibition until its closure.
- A work is only accepted officially and recorded as such once a receipt is issued by the Galleries Clerk during the registration period.
- An independent Adjudicator chosen by the organisers will judge the competition. The Adjudicator's results are final.
- The Organiser's decision on any issue is final.
- The Overall Winner will become property of the Ministry of Culture.
- Employees of GCS and of the MOC as well as their family members are allowed to take part in the competition. Subject to it being operationally possible these participant will be kept out of the judging process and will not to have any contact with the adjudicator.
- ALL artworks must be open to sale and maximum sale price should not exceed £5,000. 'Not for sale' entries will not be accepted.
- By submitting a Work(s) when you are the Artist of such Work(s), you confirm that you hold all intellectual property rights in the Work(s) and that you have obtained any third party consents required for the use of third party owned material contained in the Work(s).
- GCS reserves the right to deny admission of or withdraw a Work(s) from the Exhibition if for any reason the Work(s), or any circumstances surrounding the display of the Work(s) appears to GCS to expose it to potential or actual risk of legal proceedings or enforcement including, without limitation, the alleged breach of third party intellectual property rights.
- GCS shall have no liability to you whatsoever for any loss of business or profits, loss or damage to reputation, or for any indirect or consequential loss or damage of whatever nature, howsoever caused, whether occurring in contract, tort (including negligence) or otherwise.
- Artists must ensure that submitted works conform to all applicable Health and Safety standards and regulations.
- The Chief Cultural Officer's decision on any issue outside the adjudication proper will be final.

2. ENTRY FORM AND REMOVAL OF WORKS

- All entries must be accompanied by the entry form. The entry form must be completed in full and signed by the artist (and parent/guardian in the case of those aged under 18) to indicate acceptance of the rules and conditions of entry.
- All artworks must be submitted ready for hanging with appropriate hooks and string/wire.
- All photographs must be submitted unmounted.
- All works must carry a label affixed on the back with artist's name, title of piece and sale price.

- **Entry forms and works must be handed in from Monday 16th to Wednesday 18th August 2021 at the Fine Arts Gallery from 10am -2pm & 3pm - 6pm.**
- Entries must be collected by the artist or authorized representatives from Monday 27th September to Wednesday 29th September at the Fine Arts Gallery between 10am – 2pm & 3pm – 6pm. Works not collected will be considered unwanted and disposed of at the discretion of the organisers.

3. INSURANCE AND SALE OF EXHIBITS

- Works are submitted at the artist's own risk. It is a condition of entry and submission that the organisers, sponsors and agents shall not be liable for any loss or damage to any such work, howsoever caused. Artists are, therefore, advised to arrange proper and adequate insurance cover.
- The organisers will handle all sales of exhibits at the price stated by the artist on the entry form. A 20% sales commission will be retained out of the sale price by the organisers.

4. CATEGORIES AND PRIZES

(a) The Our Gibraltar Art Award - £750

Painting, Drawing, Prints, Digital Painting and Sculptures

- Maximum dimensions, including the frame and appropriate surround should not exceed 1 metre in height and 1.50 metres in width. Weight must not exceed 10kgs.
- Reproduction of original paintings or drawings will not be accepted.
- Artists wishing to submit multi media work should include all supporting materials such as TV screens, etc.
- All sculptures will be self-standing.
- Sculptures should not exceed 1 metre in height and a maximum width of 0.8 metres on any of its sides. Weight may not exceed 30kg and the sculpture must be able to be moved by hand by the curators.
- Sculptures, when already assembled, must fit through a standard size door.

- The curator must be able to move the sculpture to a suitable location, without this affecting the work.

(b) The Our Gibraltar Photography Award - £750

Photographs and Digital Work

- Entries must be prints and can be in black and white and/or colour.
- Photographs must be submitted unmounted, but the longest side of the photograph must not exceed 42cm.
- The participant must have originated and must own the copyright of all work submitted. This applies equally to all components of composite images, whether assembled by traditional or digital means. The use of “copyright free” or “clip art” material is not acceptable.

(c) The Ministry of Culture Award - £2,000

The Overall Winner will receive the Ministry of Culture Award with a monetary prize of £2,000.

- Winners will be announced and prizes presented by the Minister for Culture during the official opening of the exhibition which will be held at the Fine Arts Gallery on Tuesday 24th August 2021 at 7.30p.m. All participants and their guests are welcome to attend the opening.

The Overall Winner will become the property of the Ministry of Culture.
